UPCOMING PROJECT INFORMATION TRUMBULL COUNTY ENGINEER PLANS RESURFACING ON TRUMBULL AVENUE IN LIBERTY TOWNSHIP AND WEST LIBERTY STREET IN WEATHERSFIELD TOWNSHIP

Trumbull County Engineer, Randy Smith, proposes to improve Trumbull Avenue (C.H. 40) in Liberty Township and West Liberty Street (C.H. 1103 B) in Weathersfield Township, Trumbull County, Ohio. The project proposes to mill and resurface approximately 0.6 miles of Trumbull Avenue from Atlanta Avenue to State Route 193 (Belmont Avenue). Additionally, the project proposes to mill, chip seal, and resurface 0.9 miles of West Liberty Street from Salt Springs Road to the Girard City Limits. Additional work includes the replacement of one (1) culvert on Trumbull Avenue between Utah Avenue and Belmont Avenue, partial-depth pavement repairs, the installation of radar detection at the intersection of West Liberty and Salt Springs Road and the application of edge/center/stop lines and other pavement markings throughout the newly paved sections of Trumbull Avenue and West Liberty Street. This \$636,000 project is scheduled to begin construction in the summer of 2024.

During construction, traffic will be maintained at all times on Trumbull Avenue and West Liberty Street, except when it will be necessary to close Trumbull Avenue for a maximum of fourteen (14) consecutive days during the replacement of the cross culvert. The official detour for this closure will utilize Belmont Avenue, Gypsy Lane and U.S. Route 422. Construction, lane restriction, road closure/detour information will be posted along Trumbull Avenue and West Liberty Street and on the Trumbull County Engineer webpage, <http://engineer.co.trumbull.oh.us>, prior to the start of construction activities. Access shall be maintained to all adjacent properties, businesses and intersecting side streets within the construction limits for the duration of the project.

While the proposed project will not result in any substantial impacts to environmental resources, Trumbull County Engineer, Randy Smith, is seeking any comments the public may have regarding the proposed project. Project-related issues the public may wish to comment on include, but are not limited to, the effect of the project on residents, the local economy, historic or cultural resources, etc.
